ORDER U/S 12AA r.w.s. 254(1) OF THE INCOMETAX ACT 1961

1. This order is to give effect to Order of the Hon'ble ITAT, Hyderabad B' Bench, Hyderabad in ITA No 283 & 284/Hyd/2019 dt. 20.09.2019. The Society is, hereby granted registration u/s.12AA of the Act. This registration is granted **with effect from 05.06.2018** i.e the date of filing of application in Form no. 10A by the assessee.
2. The assessee is, hereby granted registration u/s.12AA of the Act. This registration is granted **with effect from 05.06.2018** onwards.
3. This registration is subject to the fulfilment of the conditions laid down u/s.12A(1)(aa) of the I.T. Act, 1961.
4. The registration does not ipso facto exempt the income unless the provisions of Sections 11, 12 and 13 of the I.T. Act, 1961 are adhered to.
5. This registration may be cancelled in terms of the provisions of Section 12AA(3), if at any stage, it is found that the activities of the applicant institution are not genuine or are not being carried out in accordance with the objects of the Society /Trust.
6. The applicant shall comply with the provisions of Section 139(4A).
7. The assessee shall not invest or deposit its funds (other than voluntary contributions received and maintained in the form of Jewellery, furniture or any article as the Board may, by notification in the Official Gazette, specify) for any period during the previous year's relevant to the A.Y.2018-19 otherwise than in any one or more of the forms or modes specified in sub-section (5) of section 11.
8. The assessee shall regularly file its return of income before the Income Tax Authority in accordance with the provisions of the Income Tax Act, 1961.
9. This assessee is henceforth assessable by the ITO (Exemptions)-1, Hyderabad.
